Non-Tariff Measures (NTMs) are policy measures, other than ordinary customs tariffs, that can potentially have an economic effect on international trade in goods, changing quantities traded, or prices or both. NTMs encompass all measures altering the conditions of international trade, including policies and regulations that restrict trade and those that facilitate it. NTMs are often incorrectly referred to as non-tariff barriers (NTBs). However, the difference between NTMs and NTBs is NTMs comprise a wider set of measures than NTBs, which are now generally intended only as discriminatory non-tariff measures imposed by Governments to favour domestic over foreign suppliers.
